Cancellation:

All cancellations must be made in writing. For any cancellation made after the reservation has been confirmed with deposit, a processing fee of \$300 will be charged. In addition, cancellation on or after April 20, 2020, will be subject to a penalty of 35% on or after May 20, or more depending on the proximity to departure, recoverable amount, and expenses incurred. Cancellations within 21 days before departure may forfeit the entire tour price. Air ticket is non-refundable after issued and the tickets are issued between 30-40 days before departure.

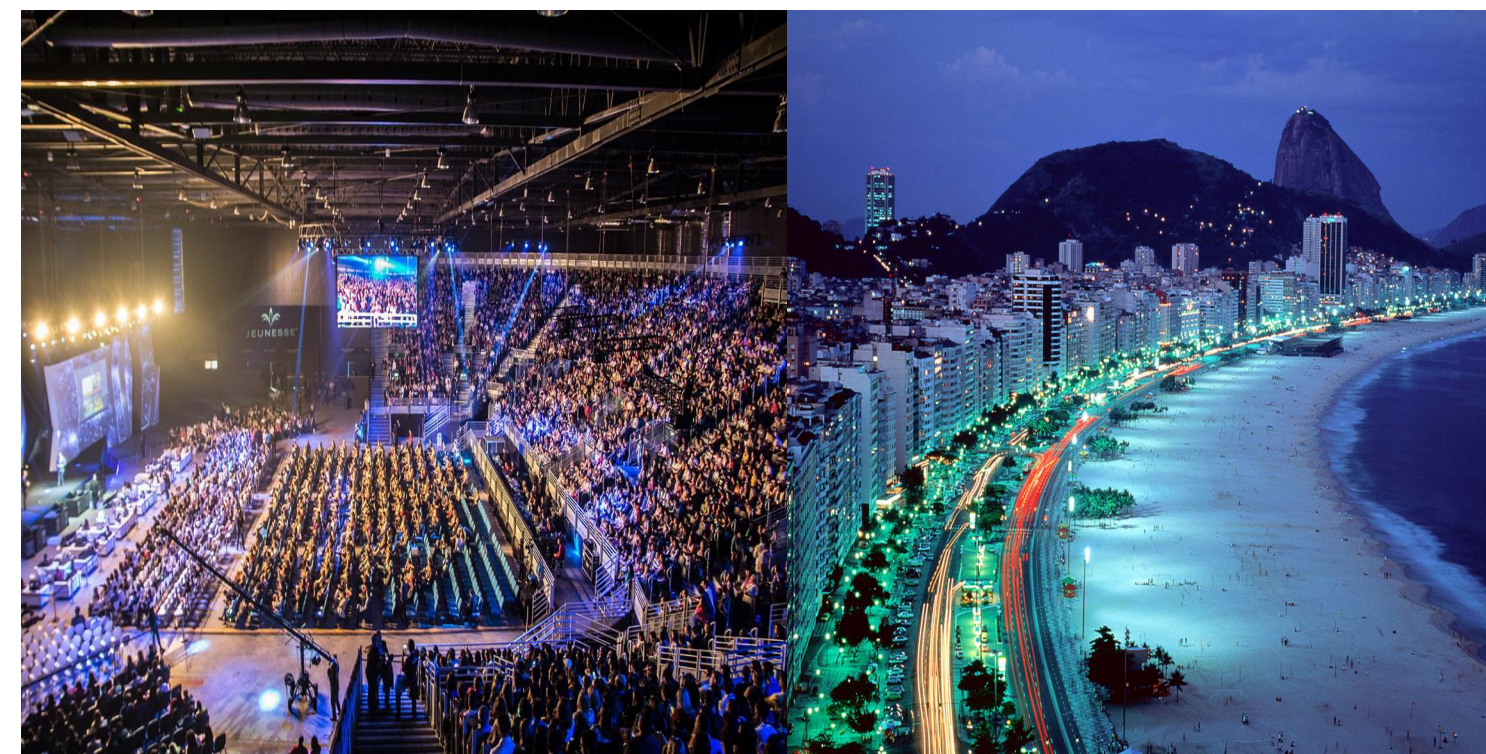

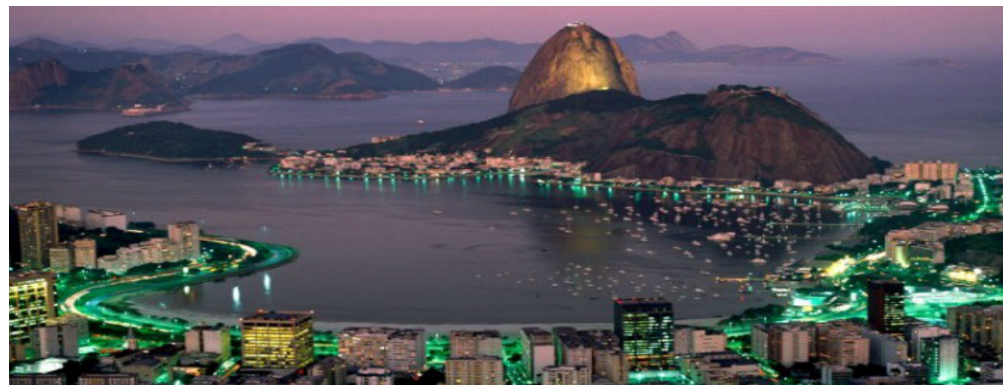
