Primary Early Voting and Election Days:

- **Maryland's Early Voting Period:** Thursday, May 2 - Thursday, May 9
Election Day: Tuesday, May 14
- **District of Columbia's Early Voting Period:** Sunday, May 26 - Sunday, June 2
Election Day: Tuesday, June 4
- **Virginia's Early Voting Period:** Friday, May 3 - Saturday, June 15
Election Day: Tuesday, June 18

Did you Know...?

- Teenagers at least 16 years old can register to vote in 19 states, including the District of Columbia, Maryland, and Virginia.
- Non-US citizens can register to vote in the local District of Columbia non-federal elections.
- Returning citizens who were convicted of criminal offense(s) or presently incarcerated, that are proven mentally competent have voting rights in the District of Columbia; and former felony convicts without a buying or selling votes offense, who are competent, are restored their rights to vote in Maryland.
- In Virginia, competent citizens convicted of a felony prior to January 2023 may have their voting rights restored, confirm their voting status, and apply for clemency through the Secretary of the Commonwealth; and those convicted of a misdemeanor and presently incarcerated of a misdemeanor can still vote.

General Early Voting and Election Days:

- **Virginia's Early Voting Period:** Friday, September 20 - Saturday, November 2
- **Maryland's Early Voting Period:** Thursday, October 24 - Thursday, October 31
- **District of Columbia's Early Voting Period:** Monday, October 28 - Sunday, November 3
- **General Election Day:** Tuesday, November 5

Same-Day Voter Registration and Identification Requirements:

- **Same-day voter registration on Election Day is offered in the District of Columbia and Maryland with appropriate proof of residence. The District of Columbia and Maryland non-first-time voters that registered before Election Day are not required to show their identification to vote in person.**
- Virginia requires identification from all in-person voters to show one form of identification, which includes a Virginia driver's license, US Military ID, a valid ID from a Virginia Institution, or a current utility/bank statement.

REGISTER TO VOTE BY TUESDAY, OCTOBER 15

Polling Place Hours:

- **District of Columbia and Maryland:** 7:00 AM - 8:00 PM
- **Virginia:** 6:00 AM - 7:00 PM

NOTE: Voters in line at closing time are allowed to vote.
